Vendor Terms and Conditions

1. Vendors shall operate the booth that has been designated to them by the Georgina Cares Kidfest Committee (hereinafter called the committee) on Saturday, May 24th, 2008 between the hours of 11am-5pm.
2. Receipt of this application and table fee does not constitute a reserved space. Vendors will be notified of application status and tables will be reserved at this time. Space is limited and is filled on a first come, first served basis.
3. Electrical outlets are very limited, but available. Spaces where vendors stand in front of the table rather than sitting behind are also available, but limited. These requests should be made upon table reservation but due to space, are not guaranteed.
4. Table rental fees are non-refundable and non-transferable.
5. Vendors agree to confine their display to the table space provided. Banners or other signage may be hung at the approval of the committee and only if it does not interfere with the surrounding vendors. All display materials must be listed on the first page of this agreement. Selling or giving away food or drinks of any kind is prohibited.
6. Vendors will set-up their table between the hours of 9:00-10:30am and complete set-up by the start of the event. The Committee has the right to approve the appearance and type of display.
7. Vendor displays must stay intact (vendor shall not remove or dismantle any part of their display during the event). Tear down and removal of all debris will take place after 5:00pm until no later than 6:00pm.
8. Vendors will, at all times, maintain a reasonable standard of conduct for a children/family event and agree to abide by reasonable rules and regulations as determined by the Committee.
9. The committee and its members are not responsible for any loss, damage or injuries occurring or suffered during the operation of the vendor's display, within the area of the operation, nor does the committee assume any liability or responsibility for financial loss of any kind.
10. Vendor(s) must attend their table at all times during the event.
11. Due to limited space, table rentals do not include an area for interactive programming. If the vendor is interested in this option, please see the vendor Activity contract.
